1. List various communication strategies used in your school to provide additional information to parents and to increase parental involvement in supporting classroom instruction.

The school will distribute bi-monthly newsletters to parents that is developed with participation of parent volunteers, faculty, principal, and staff. It includes school news, a calendar of school activities, student accomplishments, and tips for parents.

Teachers will routinely contact parents on an individual basis to communicate about their child's progress through email, phone calls, or face to face.

The school will provide to parents mid-term reports every 4.5 weeks with information regarding their child's academic progress and upcoming classroom and school events.

The school will send home a copy of the student's state standardized test results when available with an explanation of those results.

The school website will provide a link for parents and students to access their child's grades, absences, missing assignments, and discipline reports via the eSchool Home Access Center (HAC).

Upcoming events will be maintained on a master calendar accessible through the school website. In addition, events will be displayed on the school marquee.

The school will use the school website, flyers, student handbook, and parent signage to inform parents and promote parental involvement.

The Josten's SchoolWay App will be used to send school, class, and club notifications to parents, community, and students.

The school will utilize the district alert now system to provide parents with information regarding school closures, reminder of parent/teacher conferences, and other important information.

The local radio station and weekly newspaper will be used to announce upcoming events, publish honor rolls, and to acknowledge school and student achievements.

2. List the proposed parent meeting, conferences and activities regularly throughout this year and the dates providing flexible meeting times that you have planned to increase parental involvement and build staff and parent capacity to engage in these types of efforts. A financial aid night will be held in the month of February to assist parents in completion of the FASFA forms and information concerning scholarship opportunities.

Graduating students with an IEP will meet with transition counselors.

An Orientation will be held for incoming 9th graders and incoming 7th graders and their parents to discuss academic requirements and course offerings for their child's academic success.

Parents will work in conjunction with their child's teacher to help develop academic improvement plans that are required for those students who were not proficient or advanced on state assessments.

The school will encourage parents in the following types of roles and activities to increase their involvement and support for student learning: Awards day presentations, Open House, Various Committees, Orientation presentations, Parent-School Organizations.

Open House will be August 9, 2016, from 6-8 pm. An orientation will be held to discuss the Title 1 program, Smart Core Curriculum, NSLA Funding, rule changes, etc.

Two Parent/Teacher Conferences will be held. The first will be on October 20, 2016, and the second will be on March 16, 2017, from 4-8 pm.

Parents will be invited as guest speakers and to participate in Career Day to be held in the spring.

A book fair family night will be held during both parent/teacher conferences to encourage parents to participate in their child's reading interests.

The school will encourage parents in the following types of roles and activities to increase their involvement and support for student success: guest speakers, awards ceremonies, end of the year club and sports banquet, career day, various committees, Fall Festival, Homecoming Spirit Week, and PTSO.

In addition to the yearly December musical, a dramatic production will be added.

Math Family Night will be held in the fall.

Family Literacy Night will be held in the spring.

3. How will your school provide information to parents about volunteer opportunities (must include state mandated parent training)?

7. How will your school engage parents in the evaluation of your parental involvement efforts?
